

- Development and A/B testing of compliant copywriting and messaging to accompany video ads, driving further organic engagement and click throughs over time.
- Configuration and continuous optimization of campaigns to drive attractive cost per impression (CPM) and cost per view (CPV) rates.
- Optimized to increase trading volume and assets under management (net capital inflows).
